## Annual Medicare and AHIP Requirements for Brokers

Health First Health Plans and AdventHealth Advantage Plans are gearing up for the 2022 Medicare Annual Enrollment Period (AEP). The Broker Learning System found within the Broker Portal will be available for you to complete and submit your America's Health Insurance Plans (AHIP) certification. Health First Health Plans will continue to offer the AHIP certification at the discounted rate of \$125. All Medicare-required documentation can be completed electronically in the Broker Learning System.

### Completion of the Health First Medicare certification course is required prior to the start of AEP.

AHIP will open the 2022 Medicare training season on Monday, June 21. To complete the course, please follow the steps below beginning Monday, June 21.
